**SPECIAL ISSUES**

Shall the Mayor and Council of the City of Blue Hill, Nebraska, impose a sales and use tax of ½% (one-half of one percent) within the City, upon the same transactions within such municipality on which the State of Nebraska is authorized to impose a tax pursuant to the Nebraska Local Option Revenue Act, as amended, which ½% sales and use tax shall continue in effect in perpetuity from the date of imposition of such tax; the proceeds of which sales and use tax shall be used for all lawful municipal purposes which may include, but not be limited to, municipal pool construction and maintenance; and further, shall the City of Blue Hill, Nebraska, increase the budgeted restricted funds for fiscal year 2017-2018 by \$80,000.00 over its current year's restricted funds according to the adopted 2016-2017 budget?
