Absent: Roger Bohrer (District Three). The Board stood and recited the Pledge of Allegiance to the Flag. Chairman Buschow gave notice of the Nebraska Open Meetings Act Laws. Motion was made by Reiher, second by Karr to approve the minutes of the December 20, 2016 meeting. Upon roll call vote, voting to approve the minutes: Reiher, Shipman, Karr, and Buschow. Clerk Klingenberger swore in Commissioner Karr, District 2 and Commissioner Buschow, District 4 who were reelected in the 2016 Election.

Absent: Roger Bohrer (District Three). The annual Organizational Meeting began with the election of a new Chairman and Vice-Chairman. Motion was made by Karr, seconded by Shipman to reappoint Keith Buschow as Chairman. Upon roll call vote, voting in favor: Karr, Shipman and Reiher. Absent: Bohrer. Voting no: none. Abstaining: Buschow. Motion was made by Shipman, seconded by Reiher to appoint Trevor Karr as Vice-Chairman. Upon roll call vote, voting in favor: Shipman, Reiher and Buschow. Absent: Bohrer. Voting no: none. Abstaining: Karr.

At 8:40am, Jeff Kuhn, Road Maintenance Coordinator and Tom Krueger, Road Superintendent, met with the Board. The Road Crews have been using up vacation and compensatory time. They have completed the canal bridge and other bridge projects.
