The Webster County Board of Commissioners met at 8:30am on Tuesday, October 3, 2023, for their regular Business Meeting at the Courthouse in Red Cloud, Nebraska. The following Board Members were present for roll call: Dan Shipman (District One), Trevor Karr (District Two), TJ Vance, (District Three) Tim Gilbert (District Four), and Gary Ratzlaff (District Five). The Board stood and recited the Pledge of Allegiance. Chairman, TJ Vance gave notice of the Nebraska Open Meetings Act Laws. Motion was made by Ratzlaff, seconded by Karr to approve the minutes of the September 19, 2023 meeting. Voting in favor: Vance, Ratzlaff, Gilbert, Karr and Shipman. Voting nay, absent or abstaining: None. Motion was made by Ratzlaff, seconded by Gilbert to pay claims and payroll for the October 3, 2023 meeting. Voting in favor: Vance, Ratzlaff, Gilbert, Karr and Shipman. Voting nay, absent or abstaining: None. Motion carried. Motion was made by Shipman, seconded by Karr to pay County Commissioner Ratzlaff's claim. Voting in favor: Vance, Gilbert, Karr and Shipman. Abstaining: Ratzlaff. Motion carried.

At 8:35am, Road Superintendent, Paul Stoner met with the board. Paul presented the purchase agreement for the Cowles property. Discussion was had on roads and equipment maintenance.

At 9:05am, The board reviewed the Clerk of District Court report, fund balances, Imprest account and the Sheriff's quarterly report.

At 9:15am, County Clerk, Abbey Harig met with the board. Abbey discussed the Wellness Program offered by the hospital and flu shots for the employees. Shipman made a motion, seconded by Ratzlaff to cover the expense for the Wellness Program and the flu shot for employees. Voting in favor: Vance, Ratzlaff, Gilbert, Karr and Shipman. Voting nay, absent or abstaining: None. Motion carried.

Abbey then discussed an open account at Heritage bank that needs closed. Karr made a motion, seconded by Shipman to close this account. Voting in favor: Vance, Ratzlaff, Gilbert, Karr and Shipman. Voting nay, absent or abstaining: None. Motion carried.

Abbey then shared with the board issues with the courthouse basement. The board is going to table this to the October 17, 2023 meeting.

At 9:25am, Board Chairman, TJ Vance shared that he stopped in Grand Island at a Broadband meeting. The State is receiving 405 million dollars of federal money to put towards broadband. The board will have future discussions to help get the word out about this.
