The Webster County Board of Commissioners met at 8:30am on Tuesday, August 1, 2023, for their regular Business Meeting at the Courthouse in Red Cloud, Nebraska. The following Board Members were present for roll call: Dan Shipman (District One), Trevor Karr (District Two), TJ Vance, (District Three) Tim Gilbert (District Four), and Gary Ratzlaff (District Five). The Board stood and recited the Pledge of Allegiance. Chairman, TJ Vance gave notice of the Nebraska Open Meetings Act Laws. Motion was made by Ratzlaff, seconded by Gilbert to approve the minutes of the July 18, 2023 meeting. Voting in favor: Vance, Ratzlaff, Gilbert, Karr and Shipman. Voting nay, absent or abstaining: None. Motion was made by Ratzlaff, Gilbert, Karr and Shipman. Voting nay, absent or abstaining: None. Motion carried. Motion was made by Karr, seconded by Shipman to pay County Commissioner Ratzlaff's claim. Voting in favor: Vance, Gilbert, Karr and Shipman. Abstaining: Ratzlaff. Motion carried.

At 8:35am, Road Superintendent, Paul Stoner met with the board. Paul gave an update on tree removal throughout the county. Discussion was had over more of the road crew getting their CDL's.

At 9:25am, Commissioner Gary Ratzlaff presented a bid from McGill Restoration to fix the south steps. The board will discuss this further at the August 15, 2023 meeting.
